# Explanation

This form must be filled out for each batch of pigs, before delivery. The Animal Health Service which is responsible for organized health programs in the Netherlands, has certain requirements with regard to the health status of the pigs, originating from abroad to be introduced into Dutch certified herds.

These requirements must be fulfilled on the farm of origin with every delivery of pigs.

# The requirements are:

## \* Basic level, including free of Aujeszky's disease

- 1. All pigs at the farm must be free of any clinical symptoms of the diseases, mentioned below, prior to and during time of delivery.
- 2. Regular inspection of the health status of the farm of origin by a local veterinarian. A minimum of 3 visits annually, this can include routine export visits and routine visits by veterinary consultants (if applicable)
- 3. During the past 6 months, no pigs are introduced to the farm originating from farms that do not follow the requirements mentioned in this form.
- 4. The pigs have to originate from an EU-certified Aujeszky-free country or from a farm which is certified according to the Dutch requirements for Aujeszky-free certification.

#### Diseases

- Absence, for a period of at least 2 weeks of clinical symptoms of: Actinobacillus pleuropneumoniae infection; Streptococcus suis infection; anthrax; influenza; PRRS (porcine reproductive and respiratory syndrome); PMWS (postweaning multisystemic wasting syndrome); PDNS (porcine dermatitis nephropathy syndrome); vomiting and wasting disease; TGE (transmissible gastroenteritis); PED (porcine epidemic diarrhoea); swine dysentery; PIA (porcine intestinal adenomatosis); salmonellosis; mange; lice; internal parasites and swine erysipelas; no in feed medication or water medication used routinely is allowed that would prevent the expression of these diseases. In case of medication against the diseases mentioned above, persistent clinical symptoms may not occur within a period of 2 weeks after the cessation of medication.
- Absence, for a period of at least 10 years, of clinical symptoms of atrophic rhinitis. Also no Pm+ containing vaccines and no in feed medication or water medication may be used routinely that would prevent the expression of this disease.
- Presence in the herd history of the following diseases, without culling and re-stocking, is prohibited: Hog cholera; African swine fever; foot and mouth disease; brucellosis; leptospirosis pomona; Teschen disease; trichinellosis and SVD (swine vesicular disease).

### \*\* Additional level: free of toxinforming Pasteurella multocida (Pm+).

- 1. The farm must meet the requirements needed to apply to the basic level.
- 2. The farm has been tested at least 6 times for the presence of Pm+ during a period of 2 years. Specified age groups of pigs are tested concerning by Dutch requirements with negative results.
- 3. The farm does not use Pm+ containing vaccines during at least the last 4 years.
- 4. It is prohibited to use any kind of medication affecting the testresults in any way.
- 5. Breeding stock, introduced into farms that deliver pigs with the status 'free of Pm+', has to originate from farms where also tests are performed according tot the Dutch rules for the status " free of Pm+".
- 6. Pigs from tested and not-tested farms are not allowed to be transported in the same shipment.

# \*\*\*Additional level: free of sarcoptic mange

- 1. The farm of delivery is at least mange-free for 12 months and does not use acaricides anymore.
- 2. The mange-free status is controlled by 3 times yearly earscrapings or Elisa (bloodsamples) with negative results.
- 3. Pigs delivered from this mange-free farm are transported in mange-free trucks and are not mingled with pigs without a mange-free status.
